Fifth Commemoration of the Emanuel Nine

The South Carolina Human Affairs Commission (SCHAC) strives to alleviate problems of discrimination through the enforcement of the South Carolina Human Affairs Law, the South Carolina Fair Housing Law, and the South Carolina Equal Enjoyment and Privileges to Public Accommodation's Law. The Commission also seeks to establish Community Relations Councils throughout the State to foster more effective community relations, goodwill and mutual understanding, and respect among the residents of South Carolina.

In light of that role, the Commission encourages communities to commemorate End Racism Day every year on March 21. SCHAC holds an annual event for state agencies and the public in June of each year as requested by a resolution from the South Carolina General Assembly to remember the tragic Emanuel 9 Massacre. Although no event was held this year due to the COVID-19 pandemic, we ask that each of you remember the nine victims, the Rev. Sharonda Coleman-Singleton, Cynthia Hurd, Susie Jackson, Ethel Lance, the Rev. Depayne Middleton-Doctor, Senator Clementa Pinckney, Tywanza Sanders, the Rev. Daniel Simmons, Sr. and Myra Thompson. Although our hearts will forever be broken by this loss of innocent victims at the hands of racial hate, we will keep their memory alive and work to the good of making SC a better place for all people to live.

Lactation Support Act



It is the intent of the General Assembly, by this Act, to promote public health and to support those who wish to express breast milk at work by requiring employers to make reasonable efforts to provide workers with reasonable unpaid break time and space to express milk at work. This Act will not

require employers to compensate employees for breaks taken to express breast milk unless the employer already provides compensated breaks and does not require employers to create a permanent or dedicated space for use by pumping employees. South Carolina ranks far lower than the national average of breastfed infants.
